To: Pete Moe and Board

In November 2009 Orcas Island voters authorized the formation of the Orcas Island Parks and Recreation District (OIPRD) and elected five commissioners. Last week we submitted a Resolution to the County, for the November 3, 2010 ballot, requesting six years of funding for OIPRD.

If the Resolution passes, we hope to immediately begin substantive discussions with both the Funhouse and the School District as to the opportunities for cooperation and collaboration that may exist between our organizations.

OIPRD and its Commissioners cannot enter into substantive discussions with any partner until we are funded. However, in our public meetings and through articles in the local press we have openly considered "logical" places for housing OIPRD and how we might partner with others, most notably with the Funhouse and the School District, to achieve better recreational results for Orcas Islanders.

If the Funhouse Board were comfortable, at least in principle, considering collaborative options with OIPRD as soon as positive election results are confirmed, it would be very helpful for OIPRD to be provided with written confirmation of your intention and interest.

Thank you very much for the Funhouse's strong support for the formation of the Park and Rec District.

As you know, we Orcas Island Park and Rec. Commissioners have been formulating a plan over the past many months to take to the public this Fall for their consideration.

In concert with informal conversations with many of you over that time, we are moving forward with a proposal that would house the offices of the OIPRD in the Funhouse building, as it would appear that there are many mutual benefits to such an arrangement. Your director, Pete Moe, has suggested with some combination of donations, volunteer labor/materials and possibly even some OIPRD funds (assuming the levy passes in Nov.), that certain little-used museum space could be converted into offices to house the future employees of OIPRD.

It has been suggested by FH officers that in an effort to demonstrate to the public that Orcas Rec, OISD and the FH are working cooperatively <u>that</u> this occupancy would be essentially rent-free with a consideration-only fee of \$1/year.

If this is your understanding as well, may we ask that you memorialize your offer at your earliest convenience so that we may proceed with our proposal to the public at large unambiguously on the same page, reducing any chance of misunderstanding?
