

RESOLUTION NO. 55 - 2009

RESOLUTION ESTABLISHING A PARK AND RECREATION DISTRICT  
ON ORCAS ISLAND

- A. On August 25, 2009, the San Juan County Council adopted Resolution No. 32-2009 and called for an election at the 2009 general election to consider a proposition to form the Orcas Island Recreation District and called the election of commissioners to that district.
- B. On November 3, 2009, a general election was held which included the formation of the Orcas Island Recreation District and the election of commissioner to each of the five district commissioner position.
- C. The proposition to form the district was approved by the voters by with 1,652 votes in favor (71.77 %) and 649 votes opposed (28.23 %).
- D. At the November 3, 2009 general election the following candidates each received the highest number of votes for their respective positions:

Bob Eagan: 1,652  
Jim Bredouw: 1,650  
Ian Lister: 1,584  
Martha Farish: 1,527 and  
Vicki Vandermay: 795.

NOW, THEREFORE, IT IS RESOLVED by the San Juan County Council that consistent with the election results:

- 1. Pursuant to SJCC 36.69.080 the Orcas Island Park and Recreation District is hereby organized with a territory of all of Orcas Island, which property is legally described as follows:

Orcas Island is legally described as being an island located with the following sections: Section 36 in T37N, R3WWM; and Sections 9, 10, 11, 12, 13, 14, 15, 16, 20, 21, 22, 23, 24, 25, 31, 32, 33, 34, 35, 36 all in 37N, R2WWM; and Sections 30, 31, all in T37N, R1EWM; and Sections 1,12,13 all in T36N, R3WWM; and Sections 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 20, 21, 22, 23, 24 all in T36N, R2W; and Sections 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 15, 16, 18, 19, 21 all in T36N, R1WWM, all in San Juan County, WA.

- 2. Be it further resolved that pursuant to RCW 36.69.07 all positions have a short term commencing on the certification of the election and ending 12/31/2009 and a term of office as set forth below:
