# Resolution 2015-12

#### **RESOLUTION 2015-12**

A RESOLUTION BY THE ORCAS ISLAND PARK AND RECREATION DISTRICT TO AUTHORIZE THE SAN JUAN COUNTY AUDITOR TO PLACE BEFORE THE VOTERS A PROPOSITION FOR A REGULAR PROPERTY TAX LEVY.

WHEREAS, the Board of Commissioners for Orcas Island Park and Recreation District (OIPRD) desire to fund the District so that the District may fulfill its duties to provide programs and recreational services for Orcas Island citizens as set forth in RCW 36.69.130; and

**WHEREAS**, voters in 2011 approved funding sufficient for proposed OIPRD programs, services and the refurbishment of Buck Park, the full funding was never fully realized due to a decline in property assessments and thus tax distributions to OIPRD; and

**WHEREAS**, the Board of Commissioners desire to complete the 2010 originally proposed, and voter approved, improvements to the fields, courts, fences, irrigation, skatepark and backboards at Buck Park; and

**WHEREAS,** OIPRD desires for voters to approve a property tax levy to fund OIPRD authorized by RCW 36.69.145.

**NOW THEREFORE BE IT RESOLVED,** by the Board of Commissioners for the Orcas Island Park and Recreation District:

The Board of Commissioners authorizes and requests that the San Juan County Auditor place before the voters during the February 9, 2016 special election a proposition requesting approval of funding for the Orcas Island Park and Recreation District in the amount of 15 (fifteen) cents per \$1000.00 (one thousand dollars) of assessed value of property in each year for six consecutive years following voter approval, pursuant to RCW 36.69.145.

The Commissioners approve the following language for the ballot title, subject to review and approval by San Juan County Auditor and the Prosecuting Attorney:

WILL ORCAS ISLAND PARK AND RECREATION DISTRICT BE AUTHORIZED TO IMPOSE REGULAR PROPERTY TAX LEVIES OF FIFTEEN CENTS PER THOUSAND DOLLARS OF ASSESSED VALUATION FOR EACH YEAR FOR SIX CONSECUTIVE YEARS?

Attached is the Resolution for a Regular Property Tax Levy for the Feb. 9, 2016 special election to provide funding for the Orcas Island Park and Recreation District.

The Board of Commissioners of OIPRD would like to suggest that the Explanatory Statement include references for the revenue. We understand the Prosecuting Attorney's office normally drafts Explanatory Statements and therefore provide the following as suggested language only.

Suggested Explanatory Statements:

In accordance with powers granted Park and Recreation Districts via RCW 36.69.130 the OIPRD Commissioners have specified the following purposes, among others, for the revenue.

OIPRD funding may be partially used to administer and/or fund existing recreational programming and services for adults and children currently offering nearly 100 programs and serving over 1,600 participants annually on Orcas Island.

Revenue may also be used for replacement fencing, repairs to the skatepark, resurfacing the outdoor basketball court, refurbishing an outdoor volleyball court, repair to Field One and upgrades to create a baseball and soccer field, administration and maintenance of the new proposed off leash dog park, reclaiming or re-surfacing of courts for use in pickleball and tennis and repair and/or replacement of spectator seating adjacent to playing fields.

Revenue may also be used to establish an on-going fund for planned replacement of infrastructure, courts and facilities as each reaches the end of its useful life.
